- If necessary, a site audit is conducted where we visit your school to determine the compliance and appropriateness of your facilities, equipment and staff.
- We send your school two signed copies of the Auspice Agreement.
- Both copies of the Auspice Agreement are signed by your school's principal and one is returned to the College of Sound & Music Production.
- Your username and password are allocated, allowing you to access online teaching materials
- We distribute all data resources
- We send the school an invoice
- Your fees are processed
- Training commences at your school

Licence only agreement
